

Shenango on the Green – Dinner Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: Sweepstakes (the “Sweepstakes”) is open only to those who sign up at the online sweepstakes page and who are **62** as of the date of entry. The sweepstakes is only open to legal residents of **Pennsylvania** and is void where prohibited by law. Employees of **Shenango on the Green** (the “Sponsor”) and their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Sweepstakes. You may enter only once and you must fill in the information requested.
